First Aid

Application for Adult Flying Insects

METHOD OF APPLICATION: Aerial mister powered by air compressor (e.g. Stihl SR450)

PATE:

RATE:

- Apply 2.25 4.5 fl oz / 1,000 cubic feet of space to be treated
 Apply full strength to inside and outside areas of production
- Apply full strength to inside and outside areas of production facilities to knock down adult populations
- For inside use make every attempt to fill the room being treated with a fine mist or fog to insure good control

TIMING OF APPLICATION: Apply as needed to hold populations at low levels. For example, apply 3 applications at 3-5 day intervals, in order to break the breeding cycle.

Application Procedures for Immature Flying Insects (Farrowing, Gestation, and Finishing):

For use in premises that are not regularly flushed.

METHOD OF APPLICATION: Pressurized backpack or handheld pump sprayer (e.g. Hudson SP2 Backpack sprayer) RATE:

- Apply 2.8 3.5 gallon / 1,000 sq ft of space to be treated
- Apply full strength to any area where standing water occurs, example pits under pigs
- · For pits pour 0.5 gallon into the pit every 8 to 10 feet
- Apply to edges of pits and areas with high organic slurry using a pressurized pump sprayer

TIMING OF APPLICATION: Apply as needed to hold populations at low levels. For example, apply 3 applications at 3-5 day intervals, in order to break the breeding cycle.

Types of Flies Controlled

PIT FLIES Phorid and psychodidae FILTH FLIES House flies

For Cockroaches

Apply product using a pneumatic-pump sprayer. Treat areas inside and outside of production facilities, where cockroaches congregate, targeting harborage and spaces where insects may be present such as ceiling joists, walls, floors, and around pipes or other structural features. Spray to the point of saturation, contacting as many insects as possible.

Storage and Disposal

Do not contaminate water, food, or feed by storage or disposal. STORAGE: Store at room temperature in a dry area away from heat or open flame. CONTAINER HANDLING: Do not reuse this container.
