#### First Aid

#### **Directions for Use**

For use wherever insect control is needed, including barns, stables, milking parlors, dairies, swine quarters, poultry houses, calf hutches, horse barns, pens and shelters, and other associated areas. Product use permitted in other areas or facilities when product is used according to label directions.

#### For Flying Insect Control in Production Facilities

Product is ready to use – DO NOT DILUTE. Use high or low rates as desired using the chart below. Prior to application, turn off cooling and evacuation fans. Apply product using a gas-powered backpack sprayer calibrated to deliver the following rates at a fine mist. Disperse broadly throughout the environment in all locations including equipment and litter piles making sure the product contacts as many insects as possible. Keep fans off until product has settled (about 15 minutes). DO NOT remain in treated to return to the area. When used in dairy barns or facilities, close milk bulk tank lids to prevent contamination. Reapply as often as needed.

#### For Cockroaches

Product is ready to use – D0 NOT DILUTE. Apply product using a pneumatic-pump sprayer. Treat areas inside and outside of production facilities, where cockroaches congregate, targeting harborage and spaces where insects may be present such as ceiling joists, walls, floors, and around pipes or other structural features. Spray to the point of saturation, contacting as many insects as possible.

#### Storage and Disposal
